**Bankruptcy Reform: Who Really Benefits?** 

On October 1, 2002, the Center welcomed bankruptcy attorney Susan G. Castagnoli to speak on the history of bankruptcy in the U.S., and her concerns regarding the upcoming bankruptcy reform legislation facing Congress. Although bankruptcy reform has long been a favorite topic for the credit card and finance industry, it was not until after the 2000 election that serious political consideration was given to "reform." Not-so-coincidentally in the 2000 election cycle, credit card and finance companies made \$9.2 million in campaign contributions to federal candidates and the Republican and Democratic parties. MBNA America, the nation's largest credit card issuer, was the single largest contributor to the 2000 Bush presidential campaign.

The upcoming reform legislation penalizes the average consumer by assuming that all persons filing for bankruptcy are attempting to cheat the system. Debtors are forced into a symbolic debtors' prison of repayment schedules whether they can truly afford to reorganize or not. The new reforms also raise the priority of unsecured creditors such as credit card companies who give unending credit to teens and other consumers who are traditionally not credit-worthy. Finally, the reform legislation completely removes the bankruptcy judge's discretion to consider the circumstances that brought the consumer to bankruptcy, whether it be divorce, large medical bills, terrorist attacks, or corporate misdeeds leading to layoffs and the loss of retirement and severance benefits. If this version of "reform" is passed, the safety net for the average consumer will disappear while corporations are permitted to make Enronesque maneuvers to protect assets from former employees and creditors.

Bankruptcy reform legislation has been tabled until after the November election but will rear its ugly head again in January. Stay informed!

# Center's Executive Director Visits Institute of Politics, Harvard University

The Center's Director, Terry Pastika, was invited to the Institute of Politics, John F. Kennedy School of Government, Harvard University to talk with a study group exploring, "Taking on the System and Mobilizing for Justice." Over the course of a semester, students and community participants are exploring different avenues of community participation and empowerment. Ms. Pastika was invited to discuss the pioneering efforts of the Center, the concept of community lawyering and the Center's unique approach to community organizing to impact systemic change.

Study group participants learned how community lawyers assist citizens in organizing and using the law to address issues of public concern though examining issues addressed by the Center. Whether it is helping a community group that is organizing to address a county- wide problem of racial profiling and hate crimes, teaching an individual how to monitor a local school board for abuses of power, or facilitating citizen mobilization to stop a developer from building an overly dense condo development in their town, community lawyers teach citizens how to get the attention of public body decision makers, how to use the First Amendment to organize rallies, how to coalition build, how to use the Freedom of Information Act to gather information, and how to utilize various media outlets.
